We collect and use the personal data you make available to us within the scope of the entire application procedure (e.g., in cover letters, CVs/résumés, educational and professional qualifications and references, applicant's questionnaires, job interviews and information uploaded to the application portal). Furthermore, we process personal data we have permissibly acquired from trade fairs, publicly accessible sources (Xing, LinkedIn, Stepstone, Indeed), recruitment agencies, employment offices or due to recommendations. The data is processed in accordance with s. 26 subs. 1 clause 1 German Federal Data Protection Act (BDSG) in order to carry out the application procedure ('decision on the creation of an employment relationship').

If you have made available to us on a voluntary basis special categories of personal data (like data concerning health, religious beliefs or the degree of a disability), the processing thereof will only take place upon your prior consent in accordance with Article 9 para. 2A GDPR in connection with s. 26 subs. 2 BDSG.

2. We will delete your data after the application procedure has been completed.
