

Quehenberger Logistics is taking over five national companies in Eastern Europe from Logwin

Salzburg (Austria) und Grevenmacher (Luxembourg) - The Salzburg-based company Quehenberger Logistics has taken over five national companies of the Luxembourg-based Logwin AG. Two hundred Logwin AG employees are being integrated into the Quehenberger organisation in Bulgaria, Croatia, Macedonia, Romania and Serbia.

Thirteen new branches condense the Quehenberger Logistics network into a total of 79 sites. With an additional 36,400 square metres of warehouse space, Quehenberger thus manages over 190,000 square metres of warehouse and cross dock areas. The takeover in Macedonia is subject to antitrust approval. For Quehenberger CEO Christian Fürstaller the takeover is a further milestone, "We still see great opportunities in the East and are consistently improving our market position there."

With the additional seven sites, Quehenberger is hugely expanding its position in the new EU state of Croatia. Market entry only took place there last year; after the takeover a comprehensive network of sites are now operational.

With sites in Stip and Skopje, the emergent market of Macedonia is newly added to this, which is also of great interest to Quehenberger Logistics from the perspective of the textile and automotive industry. The new sites in Belgrade (Serbia), Sofia (Bulgaria), Bucharest and Cluj-Napoca (Romania) strengthen the relevant Quehenberger national organisations. With its 13 new sites Quehenberger is continuing to condense its transnational groupage network in Eastern Europe.
